1. Introduction

2. Purposes of Personal Data Processing

Your personal data will be processed as per the personal data processing conditions specified in Article 5 of KVKK for the purposes below:

- Responding to the requests of our Guests who send their reservation requests and claims through the website,
- Communicating with our Guests who made a reservation,
- Carrying out General Information Gathering (GBT) activities about our guests who want to use the area reserved for Spotting in order to ensure physical area security,
- Fulfilling legal obligations of the Company,
- Resolving legal disputes that may arise in the future,
- Protection and use of Company's legally-granted rights,

3. Transferring of Your Personal Data

Your personal data can be transferred as per the procedures and principles specified in the relevant legislation and in accordance with the terms and procedures of transferring personal data specified in Articles 8 and 9 of KVKK for the purposes below:

- To forward reservation requests to the in-Company departments to be able to record, evaluate and respond to such requests,
- To submit information to official institutions and organizations to be able to conduct General Information Gathering (GBT) activities,
- To submit information to authorized official institutions and organizations as well as private persons authorized by law to fulfill legal and administrative obligations;
- To submit information to relevant judicial authorities to carry out or monitor judicial processes,

4. The Collection Method of Your Personal Data and its Legal Basis

Your personal data are collected via automated methods through the contact forms on Company's website with your direct consent, in accordance with the first paragraph of Article 5 of KVKK and with the legal bases specified in clauses ç, e, and f of the second paragraph of Article 5 of KVKK and for the purposes stated in articles 2 and 3 of this disclosure text.
