## PUBLIC-PRIVATE COOPERATION TARIFF APPLICATION PRINCIPLES

- 1. In car parks with vehicle identification systems, parking fees are charged according to the entry and exit times shown in the system. In car parks without vehicle identification systems, if the parking permit is not returned at the exit for same-day parking, the full-day parking fee will be charged regardless of the parking time.
- 2. The monthly subscription is valid for 30 days from the first date of entry without any exits. For monthly subscriptions, in cases of multiple entries/exits, a 25% surcharge is applied to the fee.
- 3. Vehicle owners who wash their vehicles or throw trash from their vehicles into the car park, will be charged twice the parking fee.
- 4. Vehicles must leave the car park within 30 minutes of payment, or otherwise will be charged the scheduled fee for the time exceeding 30 minutes.
- 5. Car park operators can offer free parking or reduced tariffs provided they notify the DHMI.
- 6. For parking periods exceeding 24 hours, and up to seven days, customers will be charged the full day (12-24 hours) fee as shown in the fee schedule; for the remaining hours, they will be charged a fee calculated by multiplying the hourly fee (divide the full day fee by 24) by the number of hours exceeded.

## This tariff is not applicable in the following conditions:

- Vehicles of public institutions, institutions with a special budget, regulatory and supervisory institutions, social security institutions, local administrations under the scope of the general budget listed in the State Organization Central Registry System (KAYSIS) of the State Personnel Department, as well as vehicles of institutions with a special budget outside of the scope of Law No. 5018 (including vehicles leased through service purchasing) (up to a maximum of 2 hours),
- 2. Vehicles with diplomatic license plates (up to one hour),
- 3. Vehicles driven or used by disabled persons and veterans, provided that they present their documents (up to a maximum of 15 days at a time),
- 4. Private vehicles belonging to first-degree relatives of martyrs (up to a maximum of 15 days at a time),
- 5. Private vehicles used by DHMI staff (including retired DHMI staff),
- 6. Private vehicles of Directorate General of Civil Aviation personnel who are authorized to use the car parks managed by DHMI.

## **PAYMENT OF THE FEES:**

- 1. The legislative principles of the airport/terminal operator apply to the accrual, invoicing, and collection of the fees set out in this tariff.
- 2. Parking fees are paid in full when leaving the car park. Monthly subscription fees are collected in advance at the beginning of the subscription period.
- 3. Prices in the tariff include VAT. In the event of a change in the VAT rates, the pricing will be adjusted accordingly.

In order to benefit from short-term subscription fees (15 days or 30 days), users must subscribe within 3 hours of entering the car park, making their payment at either the manual payment kiosk on floor P3 of the Purple and Red Car Park or at the information desk on the departures floor, or via mobile payment.

Subscription procedures for 15 and 30 day subscriptions may also be completed using the automatic payment points on floors P2, P3, P4, P5 and P6, available in the Purple and Red Car Parks, the automatic payment points on floors P2, P4, P5 and P6 available in the Turquoise and Blue Car Parks and on floor P2 of the Yellow Car Park, within 3 hours of arrival at the car park.

\*The information desks on the departures floor only accept payment by credit card.
